**Report of the East Central and South-East Europe Division of the
United Nations Group of Experts on Geographical Names on the
work of its twentieth session**

Zagreb, 9 – 11 February 2011

Submitted by ECSEE Division Chairman*

Summary

The twentieth session of the East Central and South-East Europe Division (ECSEED) of the United Nations Group of Experts on Geographical Names, convened by the East Central and South-East Europe Division Chairman, was held from 9 to 11 February 2011 in Zagreb, Croatia.

The present report describes activities carried out at the Session and activities within member countries, including names authorities, national standardization, minority group and indigenous geographical names, toponymic databases and gazetteers, exonyms, romanization, country names, and other topics. The more details could be found in the documents of the Session.

Positive achievements in the work of geographical names standardization by participating countries can be recognized. Level of development and achievements in standardization of geographical names are not the same in all the ECSEED countries. The Session expressed special interests on the item, geographical names as the part of spatial data infrastructure and EuroGeoNames service of European geographical names infrastructure.

I. Terms of reference

1. The twentieth session of the East Central and South-East Europe Division (ECSEED) of the United Nations Group of Experts on Geographical Names convened by the ECSEED Chairman was held in Zagreb, from 9 to 11 February 2011.

IV. Opening of the Session

6. The ECSEE Division Chairman opened the Session and welcomed the delegates. He then introduced prof. dr. sc. Željko Bačić, the Director of the State Geodetic Administration, who welcomed the delegates and underlined the importance of standardization of geographical names for Croatian system of spatial infrastructure and encouraged UNGEGN work. He pointed out newly organized systematical mapping and activities in Croatia connected with geographical names developing very successfully in comparison with earlier times.

7. The Chairman then introduced Ms. Duška Paravić, the representative of the Ministry of Foreign Affairs and European Integration who welcomed the delegates and pointed out the importance of the standardization of geographical names. She

pointed out that the meeting shows how UN Group of experts on geographical names is committed to important issues in this field.

8. The Chairman announced Ms Helen Kerfoot who welcomed the participants and thanked for the opportunity to be in Zagreb. She pointed out the achievement of the organizers to collect so many participants of the Division, A lot of synergy is created through all meetings (20th ECSEE Division Session, UNGEGN WG TDFG meeting, EuroGeoGraphics – EuroGeoNames workshop). The meeting presents the opportunity to make contributions to the issues of geographical names in this part of Europe. The problems of financing have to be taken into consideration, but we are faced with great challenge in dealing with so called unauthorized geographical names. She wished to all the participants an interesting and successful work.

9. The Chairman then introduced Ms Borka Bobovec, the representative of the Ministry of Environmental Protection, Physical Planning and Construction, who greeted and warmly welcomed the participants, pointing out the topics of standardization of geographical names recognized by the international community as extremely important. The Ministry of Environmental Protection, Physical Planning and Construction is very much interested in standardization of geographical names being the integral part of spatial data infrastructure.

10. The Chairman introduced Ms Helen Kerfoot, the UNGEGN Chair inviting her to make her presentation of UNGEGN.

Helen Kerfoot: UNGEGN: overview, Divisions and news

The report provided an overview of UNGEGN organization, its important projects and recent work, UNGEGN World Geographical Names Database, the creation of Divisions illustrating their development throughout the world, their work and obligations, and also the expectations in the future. It is pointed out that people would have a lot of problems without names, but with more than 6000 languages around the world coming in many scripts, the standardization of geographical names seems to be of utmost importance bringing technical benefits, economic benefits, social benefits, and cultural benefits. UNGEGN promotes the names authorities to be established in order to have correctly recorded names data based on local usage that will be available for people to use and easy to access. The report emphasizes the importance of creating web sites mentioning the web site of this Division as a very good example.

VIII. Conclusions and recommendations

16. The Twentieth Session of the East Central and South-East Europe Division of the UNGEGN held from 9 to 11 February 2011 in Zagreb made the following recognitions, conclusions and recommendations:

(a) The Session recognized positive achievements and the progress made in the work of geographical names standardization by participating countries.

(b) The submitted national reports and documents contain a lot of information referring the various items of the agenda, and the Session recognized the importance of the submitted documents by evaluating the progress made by participating countries.

(c) The Session recognized the importance of geographical names, and the necessity to continue the important work on standardization of geographical names and to encourage the countries that have not yet done so to establish national geographical names boards.

(d) The ECSEE Division Chairman recommends the usage of a system of single layout for the ECSEED documents with the unified first page on the ECSEED documents and unique index number.

(e) The Session concluded that the countries will send national contributions (half-page reports) to the Division Chairman to implement them in to the ECSEE Division Report of 26th UNGEGN Session.

(f) The Session encourages the countries of the Division to file their credentials as soon as possible with the United Nations in New York for participation at the 26th UNGEGN Session in Vienna in May 2011.

(g) The ECSEE Division Chairman recommends continuous changing and updating of the ECSEED countries data in East Central and South-East Europe Division overview document.

(h) The Session notes the value of the Division web site and suggests its continuity and ongoing updating. The Session recommends the inclusion of documents on the history of the Division.

(i) The Session concluded that Slovenia will be the next ECSEE Division chairing country, after the next UN Conference on standardization on Geographical Names in 2012.

(j) The next informal meeting of the Division will be held during the 26th UNGEGN Session in Vienna.
